As per section 4 of the Tamil Nadu Prohibition of Ragging Act 1997, any student found directly or indirectly committing or indulging in ragging or propagating for ragging inside or outside the college are subjected to any one or all of the following punishments.

- *Two years of imprisonment.*
- *Fine to sum of Rs. 10,000/-*
- *Dismissal from the College.*
- *Shall not be admitted in any other Educational Institution.*
- *Police complaint shall be logged.*
